- Community air monitoring (July 2019)









New Regulations for Key Sources Impacting Communities





Investing in Clean Technologies in Burdened Communities

2017-2018 State Budget

- \$250 million in funding for early reductions from mobile sources
- AB 134 allocated 95% of funds to South Coast, San Joaquin, and Bay Area districts

2018-2019 State Budget

- Additional \$245 million for both mobile and stationary sources
- CARB developing updated guidelines



Emissions Reporting Regulation

- Establishes annual emissions reporting requirements for stationary sources
- Includes criteria pollutants and air toxics
- Adopted by CARB Board in December 2018
- Developing modifications for expanded scope following Board direction
